**TYPICAL CHARACTERISTICS** 25 °C, unless otherwise noted

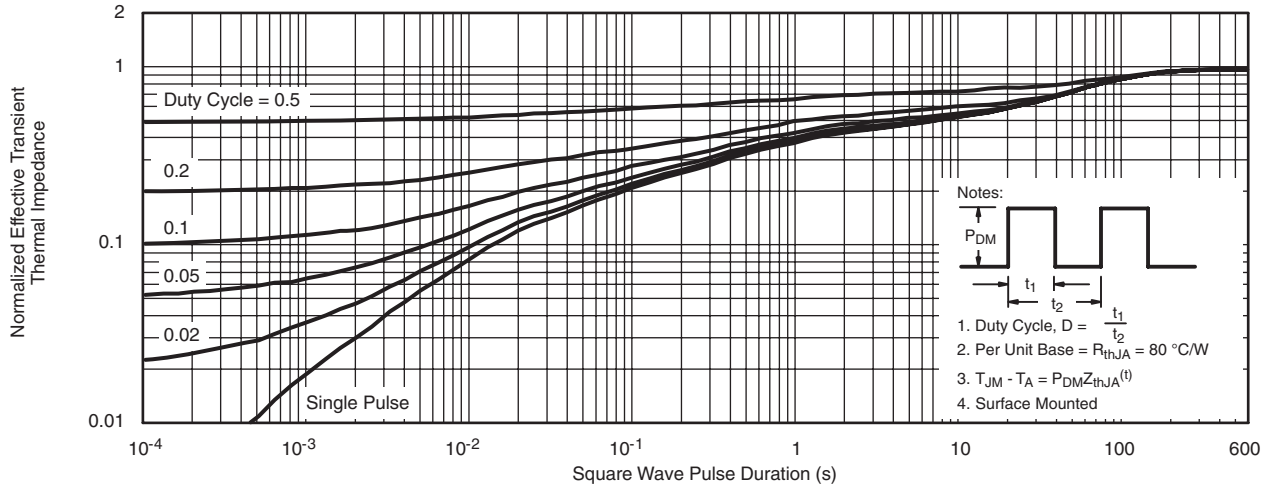

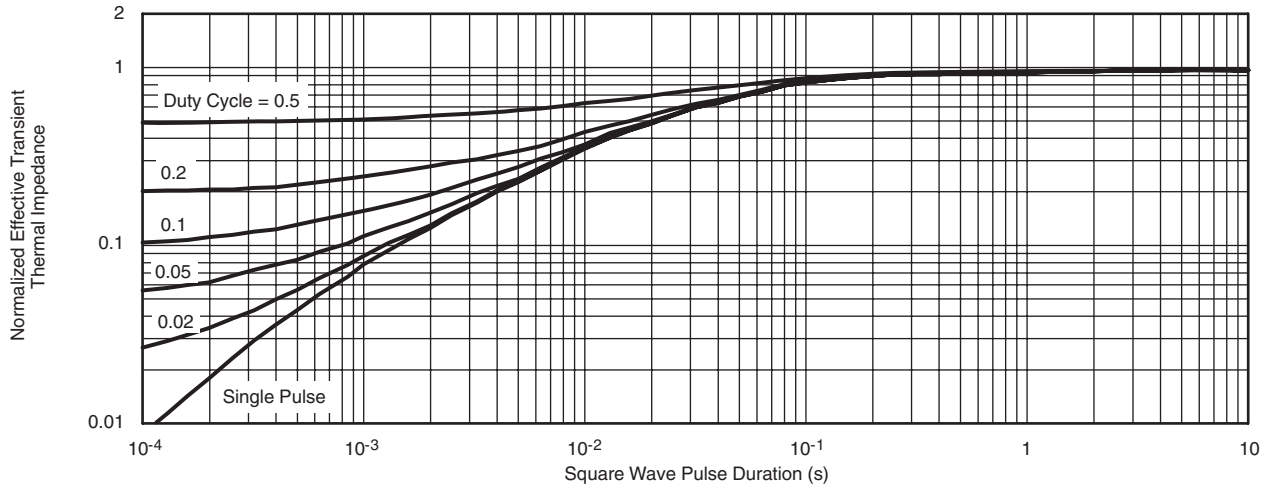
