





TYPICAL CHARACTERISTICS ($T_A = 25 \text{ °C}$, unless otherwise noted)





THERMAL RATINGS ($T_A = 25 \text{ °C}$, unless otherwise noted)




Normalized Thermal Transient Impedance, Junction-to-Ambient

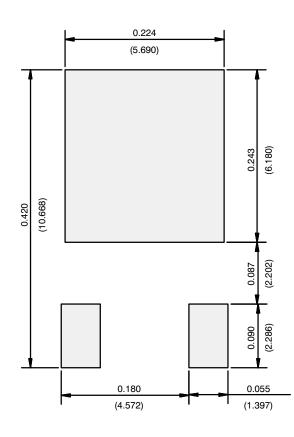
